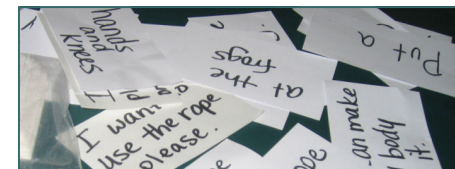

NMTSA recently became a nonprofit corporation and expanded its community services again in February 2007 through the opening of a larger facility and elementary education program. In addition to her supervisory and administrative duties, she continues to maintain her own direct caseload of persons with autism and other severe sensory and neurologic impairments. Suzanne received her advanced level training in Neurologic Music Therapy in 1999 and completed her Fellowship training in NMT in August 2002 and again in August 2005. Suzanne is the current chair of the Advisory Council for the Robert F. Unkefer Academy for Neurologic Music Therapy. She has been a therapist at Kris' Camp since 1996.

**Dena Reany, Ed.M.**, has a background in Early Childhood Special Education with a focus on Autism. She has a dual masters in Reading and Learning disabilities from Cardinal Stritch University in Wisconsin. Dena has taught for over 15 years in special education (cross-categorical, Autism integrated/self-contained programs and Learning Disabilities) and regular educational settings (4th-5th grade, and Kindergarten). Dena currently works as the lead teacher at the ACT (Assume Competence Today) school that was started based on the Kris Camp Model. This program has honed her skills and built her confidence as a teacher, facilitator, and staff trainer. The program has 7 full-time students, and one-on-one staff ratio. Dena has worked as an educator at Kris camp since the 2000 season.
